

Instructions for Abandonment Application

Apply for the appropriate application through our online portal here located under the Planning and Zoning tab. An abandonment requires review and approval by the City Commission.

Include the following with your online submittal:

- 1. Letter describing the reason for the abandonment and specify what is to be abandoned and the dimensions of the portion of easement, street or alley.
- 2. Applicant Ownership List must include signatures of all abutting property owners to the proposed abandonment.
- 3. Map, drawn to scale, showing the proposed abandonment.
- 4. Provide metes and bounds for the portion in Microsoft Word format.

When the application has been accepted and deemed complete by staff, the applicant receives an email prompting payment through the online portal. Payment must be received before the abandonment request is scheduled for a City Commission hearing.

The applicant can follow the progress of the application by the workflow through the online portal and can communicate with staff on the Portal as well.
